

ORDER FOR GRANT OF LOCATION FOR WIRES, CABLES, POLES, PIERS, ABUTMENTS, CONDUITS OR FIXTURES

By the City Council of the City of Framingham, Massachusetts notice having been given and a public hearing held, as provided by law, **IT IS HEREBY ORDERED that**

METROWEST MEDICAL CENTER [PETITIONER] be and is hereby granted sole location for and permission to construct upon, along, under or across Evergreen Street, a public way in the City of Framingham, wires, cables, poles, piers, abutments, conduits or fixtures as said Company may deem necessary, in the public way hereinafter referred to as requested in petition of said Company dated the 2nd day of February, 2018.

All construction under this order shall be in accordance with the following conditions: Conduit shall be installed in accordance with industry standard and shall be set substantially at the point indicated upon the plan marked MetroWest Medical Center, 115 Lincoln Street, submitted with the application dated February 2, 2018, revised February 15, 2018 in Framingham, Mass, recommended by the Framingham Department of Public Works in discussion with the developer. Installation shall also be subject to conditions outlined in a letter from the Framingham Department of Public Works dated February 26, 2018.

The following are the public ways or parts of ways along which the conduit referenced above may be installed under this order:


EVERGREEN STREET: Installation of conduit across the Evergreen Street R.O.W. in association with the upgrading of the hospital's emergency power supply system.

Reason: This work is necessary to maintain critical hospital operations in the event of a local or regional loss of power.

PETITIONER shall comply with the requirements of existing ordinances and such as may hereafter be adopted governing the construction.

PETITIONER shall perform all work to the requirements and satisfaction of the Department of Public Works or other such officer(s) as may be hereafter appointed by the City.

I hereby certify that the foregoing order was adopted at a meeting of the City Council of the City of Framingham, Massachusetts held on the 6th day of March 2018.




