

**ORDER FOR JOINT POLE LOCATION**

By the City Council of the City of Framingham, Massachusetts notice having been given and a public hearing held, as provided by law, **IT IS HEREBY ORDERED that**

**VERIZON NEW ENGLAND, INC.** and **NSTAR ELECTRIC dba EVERSOURCE ENERGY** be and are hereby granted joint location for and permission to erect and maintain the pole and its respective wires and cables to be placed thereon, together with anchors, guys and other such sustaining and protecting fixtures as said Companies may deem necessary, in the public way or ways hereinafter referred to as requested in petition of said Companies dated the 7<sup>th</sup> day of February, 2018.

All construction under this order shall be in accordance with the following conditions:

Poles shall be of sound timber, and reasonably straight and shall be set substantially at the points indicated upon the plan marked Petition Plan, Framingham, Verizon No. 1A2PV5Q, dated January 17, 2018, filed with said petition. There may be attached to said poles by said **VERIZON NEW ENGLAND, INC.** and **NSTAR ELECTRIC dba EVERSOURCE ENERGY** not to exceed 40 wires and 4 cables and all of said wires and cables shall be placed at a height of not less than 18 feet from the ground at highway crossings, and not less than 8 feet from the ground elsewhere. Installation shall also comply with conditions set forth in a letter from the Framingham Department of Public Works dated March 16, 2018.

The following are the public ways or parts of ways along which the pole above referred to may be erected, and the number of poles, which may be erected thereon under this order:


SUMMER STREET: Place one (1) jointly owned pole numbered T.1S/E.1S on the northwesterly side of Summer Street at a point approximately two hundred thirty-eight (238) feet southwesterly from the center line of Campello Road.

Reason: Place one (1) jointly owned pole on Summer Street to provide support to the existing pole line; and to provide for the distribution of intelligence and telecommunications and for the transmission of high and low voltage electric current.

Also that permission be and hereby is granted to the said Companies to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as may be desired for distributing purposes.

Petitioners agree to reserve space for one crossarm at a suitable point on the pole for the fire and police telephone and telegraph signal wires belonging to the municipality and used by it exclusively for municipal purposes.




