The following data analysis provides more information about Framingham residents who have received positive COVID-19 test results. This report includes cases and deaths in Long Term Care Facilities, and more. Please note that negative test results are not reported. Access to testing continues to be a challenge for many residents across the Commonwealth. This data analysis is intended to help us better understand the situation at the current time, and guide efforts to mitigate further disease transmission. This analysis is not a predictor of future trends. It will be updated weekly as additional positive cases are reported.

OVERVIEW



Data Sources: COVID-19 Data provided by the Bureau of Infectious Disease and Laboratory Sciences, Tables and Figures created by the Framingham Department of Public Health. Note: all data are cumulative and current as of 11:59pm on 02/16/2021 for the above statistics.

1. **Grey:** Less than or equal to 15 total cases in the last 14 days; **Green:** Average daily new confirmed case rate over the last 14 days: <10 cases per 100,000 population AND >15 total cases; **Yellow:** Average daily new confirmed case rate over the last 14 days: ≥ 10 cases per 100,000 population OR $\geq 4\%$ positivity rate; **Red:** Average daily new confirmed case rate over the last 14 days: ≥ 10 cases per 100,000 population AND $\geq 4\%$ positivity rate. Last 14 days = 02/03/2021 to 02/17/2021.
2. Last 14 days = 01/31/2021 to 02/13/2021
3. Change in percent positivity of all PCR tests conducted on Framingham residents compared to the previous week's (02/11/2021) report. This is based on total PCR molecular tests performed.
4. Average number of tests per day taken by Framingham residents within the past 14 days, per 1,000 population. Past 14 days = 02/03/2021 to 02/17/2021. As a reference, the State's number is around 13.41
























Deaths by Age Group in Confirmed COVID-19 Cases





Percentage of Total Population and Percent of Cases by Race/Ethnicity



- Non-Hispanic White represent 58% of the City of Framingham population and less than half of that proportion of cases at 28% of COVID-19 cases
- Hispanics represent 17% of the City of Framingham population but more than 2x that proportion of cases at 42% of COVID-19 cases
- Disparity between Whites and non-white populations would be even higher except many residents of Brazilian descent describe themselves as white.

Rate (per 100,000) of COVID-19 Cases by Race/Ethnicity



- The highest rates of positive cases are among Hispanics, Non-Hispanics Black/African American, Non-Hispanics Other and Hispanics which are more than 3x higher than the rate for White non-Hispanic
- Disparity between Whites and non-white populations would be even higher except many residents of Brazilian descent describe themselves as white.









Cases by Primary Language Last 14-Days








