

ORDER FOR CONDUIT LINES AND MANHOLES

By the City Council of the City of Framingham, Massachusetts notice having been given and a public hearing held, as provided by law, **IT IS HEREBY ORDERED:**

That permission be and hereby granted **NSTAR ELECTRIC (EVERSOURCE)** locations for and permission to construct, and a location for, such a line of conduits and manholes with the necessary wires and cables therein, said conduits and manholes to be located, substantially as shown on the plan made by **T. Thibault, dated November 12, 2021, revised December 8, 2021,** and filed herewith, under the following public way or ways of said City:


**Tripp Street - Northeasterly approximately 60± feet south of Herbert Street
Install approximately 63± feet of conduit at pole #217/1**

All construction under this order shall be in accordance with the conditions set forth in a letter dated March 10, 2021 from the Framingham Department of Public Works as follows:

1. DPW requests notification prior to the start of work to verify final location in the field and that no public utilities are adversely affected.
2. The applicant shall obtain a Street Opening Permit and a Trench Opening Permit for this work.
3. The applicant shall submit a traffic management plan to DPW for review and approval prior to construction.
4. The applicant shall fully replace and restore all sidewalk, curbing and roadway infrastructure impacted by this work.
5. All work shall conform to the City of Framingham construction standards.

The following general conditions shall also apply: Pole (if applicable) shall be of sound timber, and reasonably straight, and shall be set substantially at the points indicated upon the plan marked– **NSTAR Electric (Eversource) Tripp Street Framingham,** dated December 8, 2021 filed with said petition.


