ORDER NO. 2022-022-002
REQUEST OF THE FINANCE SUBCOMMITTEE

UPON THE REQUEST OF THE FINANCE SUBCOMMITTEE, THE CITY OF FRAMINGHAM, THROUGH THE FRAMINGHAM CITY COUNCIL, IT IS SO ORDERED:

At a Public Hearing held on June 21, 2022, the City Council vote that the General Fund Capital Project Main Library Pearl Street Entrance Project #32705 voted at the 5/17 Annual Town Meeting Article A10E appropriation is increased by \$289,271.00;

and for the payment of costs incidental and related thereto, to be spent under the direction of the Mayor or his designee; that the Mayor is authorized to acquire by gift, purchase or eminent domain, permanent easements and temporary construction easements or other interests in land for said projects; that the Mayor is authorized to take all actions necessary or convenient to carry out the purposes of this order; and, further, to meet this appropriation, the Treasurer is authorized, with the approval of the Mayor, to issue from time to time bonds or notes in such amount pursuant to the provisions of M.G.L. Chapter 44, or any other enabling authority. Any premium received by the City upon the sale of any bonds or notes approved by this vote, less any such premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs approved by this vote in accordance with Chapter 44, Section 20 of the General Laws, thereby reducing the amount authorized to be borrowed to pay such costs by a like amount;

And further, rescind unborrowed debt authorization for library capital projects that have been completed as follows:

Project #32202 Voted at the 5/2012 Annual Town Meeting Article A31B Design Library Renovations in the amount of \$29,509.00

Project #32301 Voted at the 5/2013 Annual Town Meeting Article A1 McAuliffe Branch Library in the amount of \$87,844.00

Project #32538 Voted at the 5/2015 Annual Town Meeting Article A12AL Main Library Alarm in the amount of \$207,662.00
