<u>Tuberculosis Testing</u>		
First Tuberculosis test to Framingham residents. Waiver of the fee includes, but is not limited to: the contacts of persons with confirmed or suspected case of TB; residents with radiographic or clinical findings suggesting TB; all school age children (grades K-12) who are at risk for TB; children with HIV; incarcerated adolescents; adults or children living in a shelter; and individuals unable to afford the fee.		\$20.00
Re-testing due to failure to return within return the allotted time period for the reading of the tuberculin skin test (TST).		\$25.00

<u>Food Establishment Renewal Late Fees</u>		
Late or incomplete renewal applications shall be subject to the following reinstatement late fee schedule:		
1 – 7 Business days late:	25% late fee	+ renewal fee
8 – 14 Business days late:	50% late fee	+ renewal fee
15 – 21 Business days late:	75% late fee	+ renewal fee
22 – 30 Business days late:	100% late fee	+ renewal fee
*More than 31 days late: Permit is revoked, plan review as a new establishment required and <u>DOUBLE</u> fee for new permit.		
Half the permit fee is charged if less than ½ year is left before expiration.
